	Stay Permit and Emergency Stay Permit		
1. 2.	Can Emergency Stay Permit be granted to a foreigner who has been in Indonesian territory and whose stay permit is still extendable? Suppose a foreigner finds his Temporary Stay Permit/ Permanent Stay Permit expired while being overseas, and because of the lockdown he is unable to re-enter Indonesian territory, will he also be granted Emergency Stay Permit? And can he/she apply for Temporary Stay Permit/Permanent Stay Permit extension while being overseas?	Yes, it can. Emergency Stay Permit is automatically granted to all Stay Permit holders (by an exception of Diplomatic and Service Stay Permit) without having to report to Immigration Office. No, the foreigner in such a situation is not granted Emergency Stay Permit. Emergency Stay Permit can only be granted to foreigners being inside Indonesian territory. When he leaves and does not make it re-enter the territory and in the meantime, his Stay Permit expires, in any way he cannot extend his Stay Permit from overseas. Extension of Temporary Stay Permit and Permanent Stay Permit can only be applied when applicants (foreigners) are in Indonesian territory.
